



## Centra Credit Union Teaming Up with Teachers OFFICIAL ENTRY RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

2. **How To Enter.** Centra Credit Union's Teaming Up with Teachers entry runs from midnight ET July 1, 2025, to midnight ET July 13, 2025. There will be eight separate prizes, each consisting of \$250 dollars' worth of supplies purchased from the entrant's submitted Amazon Wish List. The winners' classrooms must be in a county that Centra serves. One entry accepted per person.

*To Be Entered:* Individuals who complete and submit the entry form provided at [www.centra.org/teachers](http://www.centra.org/teachers) will be entered to win one of eight (8) prizes valued at \$250. The prizes will be distributed solely as purchases of the supplies from the entrant's submitted Amazon Wish List. All entries must be submitted within the posted time limits of the Teaming Up with Teachers promotion. All completed entries will be posted to Centra's Facebook page. Any photo submitted as an entry must be your own photo, and you give explicit permission to Centra to post by submitting. All entries become property of the Credit Union and will not be returned.

3. **Winner Selection.** There will be eight (8) Prizes announced and awarded the week of July 14, 2025. The time of the drawing will be determined at the Credit Union's sole discretion. The winners will be randomly selected from eligible entries.

4. **Prize.** There will be eight (8) Prizes, each valued at \$250.00. Prizes will be in the form of supplies purchased from the selected entrant's submitted Amazon Wish List. No cash or check will be awarded. The Prize is not transferable. The Winner will be contacted as close to the day of the drawing as possible based on available contact information and need not be present to win. The Winner is solely responsible for reporting and paying applicable state and federal taxes.

5. **Odds.** Actual odds of winning depend on the number of eligible entries received. One entry accepted per person.

6. **Eligibility.** Legal residents of the United States (except where prohibited by law) are eligible to participate and win. All participants must be at least 18 years of age, and the participant's classroom must be located in a county that Centra serves. Centra Credit Union employees, officials, and their immediate family members are not eligible for the contest or drawing.

7. **Decisions.** By entering into the drawing, entrants agree to abide by and be bound by these Official Rules, and to accept the decisions of the Credit Union as final. Entrants also agree to hold the Credit Union and each of its officers, directors, Team Members, Members and representatives, and agents harmless from any liability arising from participation, or the acceptance of a Prize. The Credit Union and each of its officers, directors, Team Members, Members, and representatives, and agents are not responsible for any negligence, claims,

liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance of the Prize awarded or participation in this promotion. The Credit Union is not responsible for stolen, lost, late, misdirected, damaged, incomplete, illegible, or postage-due mail or automatic entries; or for transactions that are processed late or incorrectly, or are lost or not received due to any reason. The Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the promotion and Prize redemption.

**8. Publicity.** The Winner agrees to permit the Credit Union to use his/her name, likeness, and submitted materials in promotional and other Credit Union materials, without additional compensation or permission, except where prohibited by law. The Winner also agrees that their name and prize amount will be given to other entrants upon request.

Compliance with Law.** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and the Credit Union in connection with the promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Indiana, without regard to its choice of law provisions.

**10. Resolution of Disputes.** Except where prohibited by law, as a condition of participating in this promotion, each participant agrees that (1) any and all disputes and causes of action arising out of or connected with the promotion, Drawing or any Prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest Columbus, Indiana; (2) the laws of the State of Indiana will govern the enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction.
